Part B

Paragraph 10

Insects

1. *Epiphyas postvittana* is included under Part B, paragraph 1, subparagraph 54. Accordingly, it is deleted from this provision.
2. 4 genus (*Chalcosoma* spp., *Heterogomphus* spp., *Trichogomphus* spp. and *Xylotrupes* spp.) and 23 species (*Atta cephalotes*, *Cadra figulilella*, *Camponotus consobrinus*, *Camponotus gigas*, *Camponotus japonicas*, *Camponotus nicobarensis*, *Camponotus sylvaticus*, *Camponotus turkestanus*, *Citripestis eutraphera*, *Citripestis sagittiferella*, *Dorcus parallelipipedus*, *Iridomyrmex purpureus*, *Messor aciculatus*, *Messor orientalis*, *Monema flavescens*, *Myrmecaria brunnea*, *Oecophylla smaragdina*, *Oncocera semirubella*, *Pogonomyrmex rugosus*, *Polyrhachis ammon*, *Prosopocoilus spencei*, *Pseudacrobasis tergestella* and *Tetraponera nigra*) were added to the regulated pest list.
3. Given that the current regulatory had already includes genus *Thrips*, the separate listing of *Thrips samoensis* (*Taeniothrips samdensi*) is deemed unnecessary. Accordingly, *Taeniothrips samdensi* is hereby deleted from the list.
4. The scientific names of 12 species (*Aonidiella tinerfensis*, *Apis mellifera scutellata*, *Archips micaceana*, *Bactrocera melanotus*, *Cillaeopeplus swezeyi*, *Dryocoetes confuses*, *Ovaticoccus agavium*, *Pinnaspis dracaenae*, *Solenopsis invicta* × *Solenopsis richteri*, *Urocera japonicas* and *Xyphon fulgidum*) were revised.

Mites

The scientific name of 1 species (*Schizotetranychus andropogoni*) was revised.

Weed

The scientific names of 2 species (*Echinochloa crus-pavonis* (H.B.K.) Schult and *Muhlenbergia reverchonii*) were revised.

Agent

The scientific name of 1 species (*Cherry short stem agent*) was revised.
